# **COPYRIGHT** POLICY



#### **1. ABOUT THIS POLICY**

This document is the Commander Copyright Policy (Policy).

In this Policy

- "you" and "your" mean the Customer;
- "we", "us" or "our" mean M2 Commander Pty Ltd (ABN 85 136 950 092); and
- "Services" includes but is not limited to telephone, internet, mobile phone, internet telephony and other telecommunications services.

This Policy applies to all Customers and any users of our Services. By acquiring or using any of our Services, you are taken to have agreed to comply with the terms of this Policy.

We may rely on this Policy where a Customer or other end users' use of the Services is not in accordance with this Policy.

### 2. WHAT IS "COPYRIGHT"?

**Copyright** refers to the exclusive rights that creators of original works are given, such as the right to protect their work from unauthorised use, duplication or distribution. ## 4. LEGAL CONTENT - FREE AND PAID

### 6. DESIGNATED REPRESENTATIVE
